3. Valid Income Tax Acknowledgement Receipt of last 3 years, Professional Tax Clearance Certificate, GST Registration Certificate, copy of Pan Card, Trade Registration certificate to be submitted electronically.
4. Registered Unemployed Engineers Co-Operative Societies are required to furnish valid Bye Law, Current Audit report, Certificate from A.R.C.S along with other relevant supporting papers.
